

Alma Festival in the Clouds 2018 Artist Application

Celebrate mountain fun and creativity at Alma's 21st annual Festival in the Clouds, July 21st & 22nd, 2018. Alma is located south of Breckenridge at an altitude of 10,578 feet. Funds raised benefit cultural, historic, recreation & community projects sponsored by the Alma Foundation. Original art and live music are **key** to our event. To be considered for this festival, items to be sold must be hand made by you. **No pre purchased or mass market materials**. Nonprofits must provide a service for the Alma community and be certified 501C3 at time of application. Nonprofits distributing information or selling items that do not conform to festival policies of **handmade (by you)** items will be set up in a separate area to enhance visibility and pay full price.

Booth fees are \$110 per 10' x 10' outdoor art space, \$220 for 10' x 15' food booths. **(Receive \$10.00 discount for preregistration for the following year, if paid in full the last day of the festival)** A tax deductible donation is requested from each participant for door prizes. Artists provide all display materials and are asked not to leave anything of value overnight. We are not responsible for theft or damage. Fees are non-refundable after July 1st. **BE PREPARED FOR EXTREMELY STRONG WINDS, RAIN, SNOW, HAIL, ROCKS, DOGS & RUGGED TERRAIN!**

If you're new to our festival, please send three representative artwork photos with your application. If you'd like photos returned, include a self-addressed stamped envelope. Artists are to be on-site and demonstrations are encouraged. You will be notified of acceptance. **RETURNING VENDORS WILL BE GIVEN SAME SPACE PREFERENCE ONLY IF APPLICATION IS RECEIVED BY March 1ST. APPLICATIONS FOR NEW VENDORS SHOULD BE RECEIVED BY JUNE 30th.** Late applications will be considered only until spaces are filled.

Our festival is held adjacent to Alma Town Hall, just East of Highway 9, Buckskin Gulch Rd. Booth hours are 10 am - 6 pm Saturday, 10 am - 6 pm Sunday. **NO EARLY TEARDOWNS as it greatly endangers visitors to the festival!** Because of our limited space we are asking that you respect the area you are given as overage greatly impacts others.
